1. CALL TO ORDER

Bolinas Lagoon Advisory Council (BLAC) Chair Ralph Camiccia called the special meeting to order at 9:15 a.m.

Advisory council members introduced themselves. Staff members from Marin County Parks and members of the public also introduced themselves.

2. OPEN TIME

Kate Bimrose, National Marine Sanctuary Resource Protection Specialist for Bolinas Lagoon, distributed copies of the annual issue of the Magazine of the National Marine Sanctuary to BLAC members, noting that Bolinas is featured on page 31 of this issue.

3. COLLEGE OF MARIN MARINE LAB

Advisory council members reviewed a draft letter to the Board of Trustees for the College of Marin voicing strong support for the College of Marin's continued use of the Marine Lab as an educational campus, either on its own or in concert with other suitable organizations, and asking if there is any information the BLAC can provide to them that would be useful when they address the future of the Bolinas marine lab facility. Suggestions for revisions to the letter were made and agreed to.

4. BOLINAS LAGOON INFORMATIONAL BROCHURE

Kate Bimrose briefly reviewed a discussion that occurred at a previous BLAC meeting and advised council members that the Bolinas Lagoon informational brochure discusses the ecological importance of the lagoon, how the lagoon has been impacted by human use and ecological changes, and why the lagoon is important. She noted that the brochure also highlights

community efforts to bring about changes to the lagoon. The Greater Farallones Association partnered with One Tam and with Marin County Parks to develop printed material about lagoon restoration efforts, and why the lagoon is so important. The new brochure includes sections describing its history, and partners who are working to protect the lagoon for future generations. The focus of restoration efforts is to prepare the lagoon to withstand future changes and for the lagoon to be able to show resilience to any future changes. A portion of the lagoon's timeline is included in the brochure. It is intended that this be a living document which can continue to be edited over the years.
